## AUDIT RESULTS

### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Program operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

### About the audit

This report contains the results of our independent accountability audit of the Washington Rural Counties Insurance Program from December 1, 2017 through November 30, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Program's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended November 30, 2019 and 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Calculation of members assessments
- Accounts payable – general disbursements and claim payments

## INFORMATION ABOUT THE PROGRAM

The Washington Rural Counties Insurance Program was formed through an inter-local agreement between several rural counties in 1998. The agreement allowed the joint purchase of insurance, joint self-insuring, joint hiring or contracting for risk management services and claims administration. The Program does not have any employees, and contracts with a private firm (Clear Risk Solutions) as its third party administrator, for accounting, claims administration, risk management and other services.

An eight-member Board of Directors governs the Program. Each county has one representative on the Board of Directors. For fiscal years 2018 and 2019, the Program reported operating revenues of about \$4.9 million and \$5.3 million, respectively.
