AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Program operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Washington Rural Counties Insurance Pool from December 1, 2015 through November 30, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Program's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended November 30, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General Disbursements – general administrative costs and claims payments
- Cash Receipting – member premiums

INFORMATION ABOUT THE PROGRAM

The Washington Rural Counties Insurance Pool was formed through an inter-local agreement between several rural counties in 1998. The agreement allowed the joint purchase of insurance, joint self-insuring, joint hiring or contracting for risk management services and claims administration. The Program contracts with a private firm for claims administration, insurance broker and risk management services and hence has no employees of its own.

An eight-member Board of Directors governs the Program. Each county has one representative on the Board of Directors. The Program operates under state law (Chapter 48.62 RCW) and must seek approval from the state Office of Risk Management within the Department of Enterprise Services for changes in its operation. For fiscal years 2016 and 2017, the Program operated on budgets of approximately \$4.4 million and \$4.6 million, respectively.
